NOTIFICATION

In exercise of the powers vested in him vide Government of India, Ministry of Home Affairs, New Delhi's Notification No. 3(4)/65-GP dated 27.01.1965 and in supersession of earlier Notifications, the Administrator, Daman, Diu and Dadra & Nagar Haveli is pleased to make the following rules regulating the method of recruitment to the post of Fireman, Group 'C', (Non-Gazetted, Non-Ministerial) in the Fire & Emergency Services in the Union Territory of Dadra and Nagar Haveli Administration namely:-

1. **Short Title and commencement:**

- (i) These rules may be called, the Administration of Dadra and Nagar Haveli, Firemen, Group 'C' (Non-Gazetted, Non-Ministerial) posts Recruitment Rules, 2014.
- (ii) These shall apply to the posts specified in column-1 of the Schedule to these rules.
- (iii) These rules will come into effect from the date of publication of this notification in the official Gazette and will relate to appointment to the various posts made on or after this date.

2. **Number of Posts, Classification and Scale of pay :-**

The number of the post, classification of the said posts and the scales of pay attached thereto shall be as specified in Column 2 to 4 the Schedule to these rules.

Provided that, the Administrator of Dadra and Nagar Haveli may vary the number of posts in column 2 of the said Schedule from time to time subject to exigencies of work.

3. **Method of recruitment, age limit, qualifications etc :-**

The method of recruitment to the said post, age limit, qualification and other matters relating therewith shall be as specified in column 5 to 13 of the aforesaid Schedule.

4. **Disqualification :-**

No person, (a) who has entered into or contracted a marriage with a person having a spouse living or: (b) who having a spouse living, has entered onto or contracted a marriage with any person shall be eligible for appointment to the service.

Provided that the Administrator of Dadra and Nagar Haveli, may, if satisfied that the such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. **Power to relax :-**

Where the Administrator is of the opinion that it is necessary or expedient so to do, he may, by order, and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

6. **Saving :-**

Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes and Scheduled Tribes, and the other special categories or persons in accordance with order issued by the central Government from time to time in this regard.
